Contribution to Learning Outcomes Assessment

In my undergraduate classes, I conduct an anonymous mid-semester review and then review the results with students and make adjustments to the class when necessary. I also administer a final anonymous qualitative assessment on the last day of class to capture students' reflection on how the course and course materials will impact them in their lives going forward. I do this because I want to encourage students to reflect on their learning. I use this assessment to identify the course materials and activities that most resonate with students and to learn how students think the content connects to their lives in the future and outside of academic contexts. In one of my regular undergraduate classes, Sociology of Law, I also started the practice of having students fill out 'exit tickets' to permit them to tell me something they found interesting, were confused by, or on which they want to have more class discussion. I review this information and use it to adjust my focus in future classes and identify areas where more explanation is needed.
